- 6. Finance N. Ciraldo
 - Revenue (Gross Profit) for November currently <u>down ~11%</u> from the Prior Month of October. This is primarily driven by the large bequest we received in October which we did not receive any bequest for the current reporting period of November



- Cat Adoptions are up ~5.4%
- Dog Adoptions are down ~42.5%
- General Donations are up ~23.5%
- Fund Raisers are down~38%
- Clinic Services rose from the prior month by ~11.3%
- Total Expenses are up ~18.8% from the Prior Month
- Compared to the prior month we are showing a decrease in **Net Revenue** by <u>~69%</u> but this is primarily due to the large bequest.
