 - P&L: February vs. January 2023
 - Revenue is lower MoM by \$53k (or -44%) due to a decline in general donations (-\$27k) and unrealized gain/loss on the investments (\$-20k)
 - Expenditures are lower MoM by \$19k (or -20%) largely due to lower spay/neuter expenses and less payments of contract expenses (e.g., clinic consultant, accounting services)
 - Net Revenue is (\$7k) and lower by \$33k (or -130%)
