 - Calendar: Funds raised as of 2/15: \$3,726 in sales, \$2,046.86 in donations [\$5,772.86 total]; Leftover calendars to go out with adopters

 - P&L: January 2023 vs. December 2022
 - Revenue is lower MoM by \$54k (or -31%) due to lower bequests (-\$47k) and fundraising (-\$13k), partially offset by increase in general donations (+\$6k)
 - Expenditures are higher MoM by \$12k (or +14%) largely due to payment of contract expenses (e.g., clinic consultant, accounting services)
 - Net Revenue is lower by \$66k (or -72%)
