 - P&L: April vs. March 2023
 - Revenue is higher MoM by \$4k (or +5%) due to large bequest (\$41k) partially offset by a decline in clinic services (-\$26k) and changes in investments (\$3k vs. \$11k previously)
 - Expenditures are lower MoM by \$11k (or -13%) largely due to lower clinic expenses (lower vet expenses/supplies: -\$8k)
 - Net Revenue is +\$17k (vs +\$1k last month)
