  - P&L: May vs. April 2023
    - Revenue is higher MoM by \$28k (or +29%) due to large bequest (\$56k), fund raisers (+\$9k), and most notably clinic services by \$25k (+100%), partially offset by changes in investments (\$-11k vs. \$2k previously)



- Expenditures are higher MoM by \$29k (or 36%) largely due to higher clinic expenses (higher vet expenses/supplies: +\$11k), clinic salaries \$13k (53%).
- Net Revenue is \$16.6k (+ \$800 from last month).
