  - Meeting with all Individuals in Finance Process
    - The Finance Subcommittee held a workshop with all individuals involved in the financial process. The goal is to document the procedures for all involvement for transparency and full knowledge of the steps of financial transactions from start to finish.
  - P&L: July vs. June 2023
    - Revenue is lower MoM by \$12k (or -13%) due to realized/unrealized investment losses in addition to not having a large fundraiser event in July. This was partially offset by an increase (~\$8k) in both cat and dog adoptions, and general donations which almost covered the lack of fundraiser in full.



- Expenditures are higher MoM by \$3k (or 3%) largely due to clinic salaries (+\$6k), vet expenses (+6k), TNR expenses (+5k) which was partially offset by Shelter Salaries (-\$4k), Spay Neuter (-3k) and vet supplies (-2k).
- Net Revenue is -\$4.6k (-\$15.5k from last month).
