- 3. Business Update J. Macrina
  - J. Colon joined to introduce herself as our new Clinic Manager. She will be starting later in January.
  - J. Macrina began setting up a Shelter Manager hiring committee, which will include representation from volunteers and Board members.

  - Social media posts about hard to place cats have been effective in finding homes for some of our shyer cats.
  - We are still getting a ton of spam and phishing attempts.

- P&L: Full Year 2023
  - Full year Revenue is \$62k higher than 2022 primarily due to investment activity. General donations are down \$50k (16%) partially offset by fund raisers up \$25k (42%). Clinic services are down \$55k (10%).
  - Full year Expenditures are up \$25k (or 2%) primarily driven by shelter salaries up \$49k (100%), overall shelter non personnel expenses up roughly \$30k (\$6k increase in pet food costs), TNR supplies and expense up \$17k and insurance is up \$5.9k (120%) over 2022. These expenses are partially offset by clinic non personnel expenses down by roughly \$20k.
  - Net Revenue is \$87k (\$40k or 84% higher than 2022).
- Statement of Financial Position: Dec 2023
  - Total Liabilities and Equity through December are at \$1.252 million, up \$94.5k from November.
