- 7. Social Media M. Kelly
  - We have two new volunteers working on Instagram on the Cat side.
  - The request for food for the community pantry was a great success.
  - No new issues with social media posts getting taken down.
- 8. Finance A. Wilansky, C. Green, R. Casey
  - Audit preparation activities have begun. Documentation is roughly 50% completed.
  - Budget development is in progress.
  - P&L: YTD 2024
    - YTD Revenue is lower than 2023 YTD by \$57k (or -17%) due to a Bequest (\$99k) that was received in 2023 and none in 2024. Without that change, Direct Donations are \$42k (or +18%). 2024 Grants are increased from \$0 to \$21.5k. Clinic Service revenue is up \$154k (or 64%).
    - YTD Expenditures are higher than 2023 YTD by \$90k (or 17%) due to Vet Expenses up \$40k (or +62%), and Clinic Non Personnel Expense (including Clinic Vet expense) up \$19k (or 25%).
    - Overall YTD Net Revenue is up \$35k or 54%
